ADOPTION AGREEMENT

1) I agree to provide nutritious food, adequate shelter, care and medical attention to this animal at all times, as per the provisions of the Cruelty to Animals Section of the Criminal Code of Canada.

2) I agree to have this animal spayed/neutered at or near six (6) months of age. I am aware that All Paws Rescue will contact me via email at this time to offer me/us a subsidized spay/neuter operation at our Rescue vet. Contact aftercare@allpawsrescue.ca for more details.

3) I agree I am contractually obligated as follows: I will not subject this animal to any cosmetic or unnecessary surgery including, but not limited to, declawing, ear cropping, tail docking or vocal cord removal, unless directed by a licensed veterinarian for reasons related to the health and welfare of the animal.

4) I agree that I understand that all animals from time to time can possess medical conditions that may be undetectable at the time of adoption. I understand that All Paws Rescue will cover medical expenses resulting from undetected and/or pre-existing medical issues up to two weeks from adoption date, providing I contact Michelle Borg/All Paws Rescue within those two weeks. Any veterinary visits that All Paws Rescue may authorize must be arranged through the Rescue with a Rescue affiliated veterinary clinic/hospital (or another location if approved by All Paws Rescue). Beyond the two-week clause as aforementioned, All Paws Rescue Services will not be responsible for costs incurred after adoption in relation to animal health.

5) I agree that pets may exhibit normal but potentially undesirable behaviours after adoption (including but not limited to aggression, house soiling, biting, scratching etc.). All Paws Rescue provides no warranty or assurance with regards to the behaviour of the animal being adopted. All known personality traits are advised prior to adoption.

6) If adopting a cat, I agree and am contractually obligated as follows: I will keep the cat indoors at all times, unless under constant supervision/on leash.

7) I agree that unless otherwise agreed upon, when two or more bonded animals are adopted together they will remain living together in proximity to and regular socializing with each other.

8) I agree not to euthanize the animal except in the event of terminal illness or injury of the animal, or old age accompanied by pain and suffering, as determined by a licensed veterinarian. Only a licensed veterinarian may euthanize the animal.

9) I agree to notify aftercare@allpawsrescue.ca immediately if: a) I change my address within 6 months of the adoption date, b) if the animal is lost or stolen at any time, or c) animal becomes ill within 30 days of the adoption date.

10) I agree to notify All Paws Rescue Services/Michelle Borg immediately if I am unable to keep the animal, with the understanding that All Paws Rescue will assist me in finding a new home, or will place the animal in temporary foster care if a new permanent home is not immediately available.

11) I agree and am contractually obligated as follows: I will not place this animal elsewhere without the express permission of All Paws Rescue/Michelle Borg.

12) I agree to accept follow-up inquiries on the status of this animal from Michelle Borg or any All Paws Rescue representative, and to respond to them in a timely manner.

13) I agree that I have read and fully understand the entirety of this agreement.
